#### **INTRODUCTION**

Shikari, Trilokpur & Fatehpur are popularly known as -Teen Kothi area of the Kullu District of Himachal Pradesh is remarkable for its scenic beauty, healthy climate and pure environment. There are many primary and secondary educational institutions in this area but the need for a Degree College was being felt for long times. Consequently on a historic day in 2014 while addressing a public meeting at Gadagusain, Late Sh. Virbhadra Singh Ji, the former Chief Minister of Himachal Pradesh announced the opening of a Degree College in Gadagusain Area of Kullu District. The local people constituted a Land Acquiring Committee which worked tirelessly and nearly 33 Bighas of land surrounding the HHPWD rest house was allotted for the construction of the college complex.

To begin with the faculty of Arts and commerce were introduced from the building of GSSS Gadagusain during the session 2014-15. There were 118 students in B.A.-I during the session 2014 -15 and among them 69 students were boys and 49 students were girls. All of them will be remembered forever as the first batch students of this college. Late Sh. Virbhadra Singh Ji, the then Chief Minister of Himachal Pradesh laid the foundation stone of Govt. Degree College at the proposed site at Gadagusain on 25<sup>th</sup> Feb., 2014 and after 5 years of tireless work by college authorities to process FCA case and with the help & contribution of the former Chief Minister Hon'ble Jai Ram Thakur Ji, the work of college campus has started since March 2019. At present in BA level degree course we have English, Hindi, History, Sociology, Political science & Music as subjects and conventional fixed course B.COM. From mere 118 students in 2014, the students' strength in this institution rose to 123 during last 2023-24 session. The commerce classes have also been sanctioned in this college from current 2014-15 session. The admission to this academic session will start in accordance with the university schedule from 18<sup>th</sup> of June, 2019. In the light of newly introduced year based system, the admission through counselling and following merit will be given in each subject and on Roll over basis to 2<sup>nd</sup> & 3<sup>rd</sup> Year students under CBCS system.

## **ADMISSION PROCEDURE**

- 1. **PROSPECTUS CUM ADMISSION FORM:** to be purchased from the college office from the College clerk.
- 2. **COUNCELLING COMMITTEE:** First year students to appear before counselling committee to decide about their main/additional and other subjects.
- 3. **ADMISSION COMMITTEE:** -Approach the admission committee with duly filled-in admission form and enclose concerned documents as per the requirement stated in the admission form. (For Fresh students seeking admission for the first time the certificates of Matriculation, +2, and SC/ST/OBC/IRDP etc.).
- 4. **ADMISSION CONVENER-**Approach the convener of admission committee in the college for final verification of admission documents.
- 5. **PRINCIPAL/VICEPRINCIPAL:** Approach the Principal/vice principal for getting admitted in the college.
- 6. **PAYMENT OF FEE:** -Approach the collegeoffice and make the payment to Fee clerkforgetting admitted in the college. A student has to pay the prescribed fees within stipulated time period; otherwise his/her admission stands cancelled. Admission is approved after payment of fees only.
- IDENTITY CARD: -Student will get Identity Card issued from the college office from the college librarian after showing fee payment receipt to him within15 days from the date of admission.
- 8. **APPROVAL OF IDENTITY CARD:-** After duly filled-in Identity Card, it has to get approved / signed and stamped from the college office from the dealing clerk/ Asstt..
- IDENTITY CARD TO BE SIGNED BY THE PRINCIPAL: Approach the Principalfor signature on the identity card (after getting first approved /signed and stamped form the college office).
- 10. **KEEP IDENTITY CARD SAFE**:-Do not loseyouridentitycard. Duplicate identitycardwillnot be ordinarilyissued. Itcan be issued onlyafter dulyregisteringFIR and on showingthe receipt for same and paying cost of new identity card.

# **GUIDELINES FOR ADMISSION:**

All admissions to B.A./ B.Com 1<sup>st</sup>and 2ndYear & 3<sup>rd</sup> year will be made as per the Admission Schedule 2024-25. From Academic Session 2019-20 onwards the University of Himachal Pradesh and Department of Higher Education Govt. of Himachal Pradesh has introduced Yearly System in B.A./B.Com classes.

## **Eligibility For Admission:**

A pass in the Senior Secondary (+2) Examination (Academic Stream) conducted by the H.P Boardof SchoolEducation (orin case of Shashtri, passin Prak Shashtrifrom Sanskrit Collegesaffiliated to the SPU) or an examination accepted as equivalent thereto by the various bodies of the H.P. Uni- versity

- (i) Provided that the candidates who have passed the qualifying examination with science stream shall be given preference in admission to B.Sc. / B.C.A programme.
- (ii) Provided that the candidates who have passed the qualifying examination with commerces tream shall be given preference in admission to B.Com. / B.B.A programme.
- (iii) Provided that the candidates who have passed the qualifying examination with Mathematics as one of the subjects shall be given preference in admission to B.C.A programme. Ordinance 1.4 of H.P. University states further that a student seeking admission to B.A. 1styear with Mathematics as one of the subject of study should have obtained either 45% marks in aggregateor45marksinmathematicsat+2level.(5%marksofRelaxationforSC/STstudents). (Fordeterminingtheeligibility,0.5percentandaboveshallbeconsideredasonepercent).
- (iv) Provided that the candidates who have passed Prak Shashtri examination from Sanskrit Colleges shall be given preference in admission to Shashtri programme.

# **Choice Based Credit System (CBCS)**

Pursuing the aim to enhance and give boost to enrolment in Higher Education, University Grant Commission hasproposed Rashtriya UchtarShiksha Abhiyan (RUSA). Under this programme, the CBCS hasbeen introduce with a vision to enhance the quality of education. The UGCCBCS system

has been approved and adopted by the Department of Higher Education and SPU Mandi since session 2023-24 and the admission for the session 2023-24 will also be in accordance with the system.

## **Outline of Choice Based Credit System:**

**1. Core Course:**6 Discipline Specific CoreCourses (DSC) (2 per subject) in B. Sc. & 4 DisciplineSpecificCoreCourses(DSC)(2persubject)and2CoursesofEnglishand Hindi in B.A. B.Com.

**2. Elective Course:**Generally, a course which can be chosen from a pool of courses and which may be veryspecific orspecializedoradvancedorsupportivetothedisciplinesubjectofstudyorwhichprovidesanextendedscopeorwhichenablesanexposuretosomeotherdisciplin e/subject/domainornurturesthecandidatesproficiencyskillis called an Elective Course.

**Discipline Specific Elective (DSE) Course:** (2 each for regular courses): Elective courses offered under the main disciplinesubject of study are referred to as DisciplineSpecific Elective. The list provided under this category are suggestive in nature and each University has complete freedom to suggest their own papers under this category based on their expertise, specialization, requirements, scope and need. The University Institute mayalsoofferdisciplinerelatedElectivecoursesofinterdisciplinarynature(tobeofferedby main discipline subject of study).

**Generic Elective(GE)Course:**(2 each for B.A. B.Com. regular courses): An electivecoursechosenfromanunrelateddisciplinesubject, with an intention to see kexpo-

surebeyonddisciplinesofchoiceiscalledaGenericElective.Thepurposeofthiscate-

goryofpapersistoofferthestudentstheoptiontoexploredisciplinesofinterestbeyond the choices they make in Core and DisciplineSpecific Elective papers. The list pros ided under this category arc suggestiv *e* in nature and each University has complete freedom to suggest their own papers under this category based on their expertise. specialization. re- quirements. scope and need.

## **CREDIT SCHEME**

- An Undergraduate degree in Humanities/ Social Sciences/ Commerce may be awardedif a student completes 4 core courses each in two disciplines of choice, 2 core courses eachinEnglishandHindi/MIL,respectively,2AbilityEnhancementCompulsory Courses (AECC), minimum 4 Skill Enhancement Courses (SEC), 2 courses each from a list of DisciplineSpecific Elective courses basedonthetwo disciplines of choice selected above, respectively, and two courses from the list of Generic Electives courses.
- An undergraduate degree in science disciplines may be awarded if a student completes4 core courses each in three disciplines of choice, 2 Ability Enhancement Compulsory Courses (AECC), minimum 4 Skill Enhancement Courses (SEC) and 2 courses each from a list of Discipline Specific Elective courses based on three disciplines of choice selected above, respectively.

## Age limitation for admission 1<sup>st</sup> year Class(Ordinance3.3):

The Students who has attained the age of 23 years (25 years for girls students only), the vice chancellor shall have the powers to permit age relaxation for reasons to be recorded in writing upto a maximum of six months. The upper age limit to be raised by three years in case SC/ ST Stu- dent.

## **Relaxation for SC/ST students:**

- i) Relaxation of 5% marks in aggregate for the admission in commerce and science. However, the 45% marks to be required to get admission in Science and Commerce.
- ii) Relaxation of 3 years of ageford etermination of upperage limit for admission.
- Note:- Asperinstructions contained vide letter No Shiksha-H (8)9(2) II-7-6-DE, H.P, dated 20-6-92 the students belonging to SC/ST will be given 5% relaxation of marks for the purpose of admission.
- □ For II Year & III Year students: the combination of same main/additional subject at 1st year/2<sup>nd</sup> Yearlevel shall continue.

As per letter no. 4-9-2007-SPU (Acad) dated 23-6-08, the admission to BA/BCom II year and III Year students will be held according to roll on system without waiting for the declaration of resultby H.P.U.

## Admission limitation for failure students, Ordinance 3.4:

- i) A student who has failed in more than 75% of subjects or who has failed twice in the same class is not entitled for the admission in the College.
- ii) A student disqualified/expelled/ rusticated by any University shall not be admitted to any class/course during his/her disqualification period (H.P.U. ord. No. 3.6)

## Migration: is permitted as per Ordinance3:11as stated below:

The admission of students migrating during same session from one affiliated college or institution (including the Directorate of Correspondence Courses) to another affiliated college or institution (includingtheDirectorateofCorrespondenceCourses)shallbegovernedbytheregulations

## **Eligibility for University Examination(Ordinance6.2):**

- (a) In order to be eligible to appear in the University examination, a candidate should have to put in 75% attendance in each of the concerned courses in theory as well as in practical. Provided that in thecase of a candidate provisionally admitted to a higher class, but reverted to the lower class, as provided therein, this condition shall only be required to be fulfilled in respect of attendance or assignments as the case may befrom the date of his/her reversion to the lower class.
- (b) A candidate on rolls of a college affiliated to or maintained by University, shall be admitted to the examination on production of a certificate from the Principal of his/her college show- ing that he/she has obtained in House Examination:
  - i) <u>20%marksineach subject,compulsoryandelective OR</u>
  - ii) <u>25% of the aggregatemarks of the entire compulsory and elective subject.</u>

## Requirement in minor/ house tests:-

A student should secure a minimum of 20% in each subject or 25% in aggregate out of a total internal minor/ house examinations for awarding him 45% marks of internal assessmentand 5% marks for attendance.

## **Enrolment of a student under re-examination system:-**

For enrolment of a student under e-examination system, the fee has to be deposited through SBI branch only; whereas, some other CBS enabled banks have also been authorised for depositing the examination fees. All the students at the semester end have to online fill their examination forms and deposit requisite fee through challan generated by this process and only thereafter they can get their roll number slip from online portal. Students must keep secure their ID and password for future. In every semester at the end for university examination they will have to fill the e-examination forms through this ID and password generated in first semester. B.A. III year students will have to fill offline examination form as per previous years practice.

## **RULES AND REGULATION IN FORCE**


